









NOTICE OF PROPOSED GRANT OF EXPLORATION LICENCES

Nature of act(s): The grant of an exploration licence under the *Mineral Titles Act 2010* authorises the holder to conduct activities in connection with exploration for minerals for a term not exceeding 6 years and to seek renewal(s). The term for which it is intended to grant the exploration licence/s referred to in this notice commences from the date of grant. Native Title Parties: Any person who is, or becomes a "native title party" within the meaning of the *Native Title Act 1993* is entitled to the negotiation and/or procedural rights provided in Part 2, Division 3, Subdivision P of the *Native Title Act 1993*. Under section 30 of the *Native Title Act 1993*, persons have until 3 months after the notification day to take certain steps to become native title parties in relation to this notice. Enquiries concerning becoming a native title party should be directed to the National Native Title Tribunal, GPO Box 9973, Melbourne VIC 3001, or telephone (03) 9920 3000.

Expedited Procedure: The Northern Territory Government considers that the acts are acts attracting the expedited procedure as defined in section 237 of the *Native Title Act 1993*. The exploration licences referred to in this notice may be granted unless an objection is made by a native title party to the statement that the act is one which attracts the expedited procedure. Such an objection must be made to the National Native Title Tribunal within 4 months of the notification day.

Objection or Submission, Section 71 of the *Mineral Titles Act 2010*: The landowner(s) of land in respect of which the following applications are made, may lodge an objection to the grant of the exploration licence application; any other persons may lodge a submission. Objections and submissions must be lodged in writing with the Department of Primary Industry and Resources, at the above mentioned address or emailed to titles.info@nt.gov.au, within 30 days from the relevant Notification Date which is set out below.
